



### CAR RAFFLE OFFICIAL RULES

1. Sales begin at 9 a.m. MST on March 15, 2021 and close at 3 p.m. MST on May 13, 2021.
2. Drawing will be held on May 13, 2021 at 4 p.m. MST at Underriner Motors, 3671 Pierce Parkway, Billings, MT 59106.
3. One winner will be awarded a 24- month lease of a new 2021 Hyundai Elantra SEL (Hereafter referred to as the "Car.") Exterior Color: Electric Shadow; Interior Color: Black. Lease includes 12,000 miles per year. Underriner Motors is responsible for title and licensing fees for 24 months. Should this Car be unavailable at the time of awarding, Underriner Motors reserves the right to substitute another Car of equal or greater value. There is no cash alternative in lieu of the vehicle lease. Car may not be substituted or exchanged by winner. Terms of lease subject to change.
4. The approximate retail value of the Car for a two year lease is \$14,280; subject to change.
5. Net proceeds from the raffle benefit United Way of Yellowstone County.
6. By purchasing a ticket, purchaser agrees to all terms and conditions as set forth in these Official Rules.
7. There is no limit to the number of tickets an individual or business may purchase. Odds of winning are based on the total number of tickets sold. A maximum of 6,000 tickets will be available for sale.
8. Only Montana residents may participate.
9. Void where prohibited.
10. Must be 18 years of age or older to participate and win.
11. Raffle ticket for \$25 each or 3 for \$60.
12. Only cash, check or debit card will be accepted to purchase a ticket. Credit Cards are NOT accepted for gambling in the state of Montana for raffles.

  - By Mail: Mail check and ticket request to: United Way of Yellowstone County, 2173 Overland Ave., Billings, MT 59102. Checks should be made out to United Way of Yellowstone County. The ticket stub(s) will be returned via mail as a receipt and confirmation of purchase. *All mail purchases must be postmarked by Tuesday, May 11, 2021 to be included in the drawing. United Way of Yellowstone County is not responsible for entries lost in the mail or otherwise not received.*
14. One ticket will be selected through a random drawing, as the winner, from all raffle tickets purchased.
15. Ticket holders do not have to be present to win.

16. Tickets and the winners' rights are not transferable.
17. Winner will be notified by telephone, email, and mail using the information entered upon registering. Winner will be notified in writing in the Winner Notification Agreement ("WNA"), which will be sent by certified, return receipt U.S. Mail to the address provided by that winner. Winner will have seven (7) days from the date of receipt of the WNA to accept the Car by executing and returning the WNA pursuant to the terms stated therein. Failure to execute and return the WNA and accept the Car "as is," timely, and pursuant to the terms stated in the WNA, will automatically result in forfeiture of the Car, with no substitution or alternative Car available to the original winner. In the event of forfeiture, the next winner that was selected will be awarded the Car.
18. Car will not be awarded, and will be forfeited, if the ticket was issued in exchange for a check returned for "insufficient funds" or for a debit card charge deemed "declined," "invalid," or "stolen."
19. In accordance with IRS rules and regulations, the cost of tickets is not tax deductible.
20. All sales of raffle tickets are final and there will be no refunds.
21. Acceptance of the Car is permission for United Way of Yellowstone County, Underriner Motors, and other media sponsors to use the name, picture, video image, and relevant quotes of winner in print, broadcast, online, and social media.
22. The IRS requires that taxes on prizes valued greater than \$5,000 must be paid upon acceptance and before the Car may be delivered to the winner. Taxes are estimated at \$3,421.
23. By law –Winner will receive an IRS Form W-2G for the value of winnings from United Way of Yellowstone County.
24. If there is more than one name on an entry, the Car will be awarded to the first name listed on the entry as the winner, so long as that person is 18 years old or older.
25. Employees, agents, representatives or affiliates of United Way of Yellowstone County, Underriner Motors, its affiliates, participating sponsors, and their immediate family members and household members are not eligible to participate. "Immediate Family" is defined as the spouse, parents, grandparents, great-grandparents, brothers, sisters, children, grandchildren, and great-grandchildren of the employee and his/her spouse. This definition also includes individuals for whom an employee is the current legal guardian or individuals who are not legally related to but who reside with an employee. ("Step" relationships also are covered by this definition.)
26. Winner expressly releases Underriner Motors, Hyundai, United Way of Yellowstone County, and their affiliated companies and organizations, parents, subsidiaries, agents or contractors and their employees, board members, officers, and directors from any and all claims, demands, damages, and/or liability of any nature whatsoever that winner has or claims to have relating to the herein contest, and without limitation, any and all known or unknown claims for damages or injuries arising out of said contest, whether founded in fact or in law.
27. United Way of Yellowstone County and Underriner Motors, and any associated sponsors maintain no control of the personnel, equipment or operations of any supplier and assume no responsibility for any financial loss, personal injury, property damage, other loss, accident, delay, inconvenience or irregularity which winners may experience by reason of (1) performance or nonperformance by any supplier; (2) wrongful, careless, negligent, or unauthorized acts or omissions on the part of any supplier or its employees, or on the part of any other party not under the control of United Way of Yellowstone County and Underriner Motors; (3) any acts of God, acts or omissions of third parties, damage or loss associated with any terrorist activities, social or labor unrest, mechanical or construction failures, disease, local laws, climactic conditions, or other conditions or developments. United Way of Yellowstone County and

Underriner Motors shall in no event be liable for special or consequential damages arising from the use of vehicle. Participants hereby release United Way of Yellowstone County, Underriner Motors, and any associated sponsors from any such claims.

28. Violations of any of these rules or attempts to win by fraud, deception, or cheating shall result in forfeiture of the Car won by fraudulent means.
29. United Way of Yellowstone County has filed Form 46 with the Montana Department of Justice, Gambling Control Division.

**What are the winner's responsibilities?**

1. To claim the Car, winner must provide two forms of identification (including a copy of a current, valid driver's license), personal information required to qualify for financing approval from Underriner Motors and/or Hyundai Motor Finance, be 18 years of age or older, and show proof of adequate liability insurance.
2. Winner will have seven (7) days from the date of receipt of the Winner Notification Agreement ("WNA") to accept the Car by executing and returning the WNA pursuant to the terms stated therein. Failure to execute and return the WNA and accept the Car "as is," timely, and pursuant to the terms stated in the WNA, will automatically result in forfeiture of the Car, with no substitution or alternative Car available to the original winner. In the event of forfeiture, the next winner that was selected will be awarded the Car.
3. Winner is responsible for mileage fees of .15 cents per mile over 24,000 miles, and any excess wear and tear charges as determined by Underriner Motors.
4. At the end of the 24-month lease, Winner will turn in the car to Underriner Motors or buy out the lease based on the remaining residual value, which will be determined May 13, 2021.
5. As a condition of the award, the winner must agree to hold harmless United Way of Yellowstone County, Underriner Motors, and their parents, subsidiaries, affiliates, agencies, officers, directors and employees from responsibility for damages, losses or injuries, including death, personal injury or property damage, due in whole or part, directly or indirectly, from participation in this promotion or acceptance, possession, use or misuse of the Car.
